The pre-marriage series provided by Emmaus Counseling Center is a series of three one-hour counseling sessions designed to highlight key areas of a couple's relationship. By encouraging couples to share information about themselves during the sessions, our hope is that the couple will discuss and explore these areas in more detail on their own, between sessions, thus expanding the information they have about themselves and one another.

The series is not intended to provide "therapy" for either the individuals or the couple, nor is the goal to work on specific problem areas. Rather, the intent of the experience is to allow couples an opportunity to examine their readiness for marriage and to discover their areas of strength and needed growth.

The cost of the series is \$340, payable at the first session unless otherwise arranged. Scholarships may be available to those who cannot afford the entire series fee. It is understood that this fee is non-refundable in whole or in part. Since the marriage preparation series is a professional service, pre-arranged appointment times are reserved for the client couple. Clients will be charged for missed appointments cancelled with less than 24 hours' notice.

Information discussed in the sessions is confidential. With the couple's signed consent however, the counselor will provide a written evaluative summary of his/her contacts with the officiating clergy.
